JOB PURPOSE

Responsible for administration of the Bank’s nCino platform including lending, CRM, deposit accounts, and treasury management platform. The candidate will work closely with relevant stakeholders to facilitate an efficient business process to increase productivity. The Senior Technical nCino Admin will also serve as a technical liaison between departments and third-party integrations.

DUTIES AND RESPONSIBILITIES

1. This position is 80% Technical (drawing on technical and/or CRM product knowledge in advanced configurations of the Salesforce.com and nCino platforms), 20% Analysis
2. Salesforce configuration changes, including (but not limited to): Workflow, Process Builder, Flow, assignment rules, approval processes, fields, page layouts, record types, dynamic layouts, apps, actions, custom settings, dashboards, and reports specifically for Commercial Lending and Treasury Management
3. Design and configure solutions, focusing on the gold standard as a best practice, scalable solutions with a focus on exceptional user experience
4. Analyze business requirements, procedures and problems and serve as a technical solution strategist
5. Develop reports, custom report types, dashboards and processes to continuously monitor data quality and integrity
6. Identify unused or underutilized platform features that can raise the bar for the business and platform
7. Manage operational requests such as creating rules around workflow, validation, fields, advanced formulas, custom objects, flows, etc.
8. Assist in creating documentation of processes, policies, application configurations and continual modifications and help related materials
9. Assist with the communication of any platform changes to our Salesforce Support Manager & Trainer
10. Collaborate with third-party vendors for custom development projects

11. Proactive system maintenance including Security Reviews and Health Checks
12. Assist management with vetting, selecting, and implementing new Salesforce-related technology solutions
13. Provide technical support and troubleshooting assistance to users in the field for Commercial Lending and Treasury Management
14. Monitor queues and resolve escalated support tickets
15. Attend webinars, training, and conferences to maintain a full understanding of the capabilities and functionality of all applications we use within Salesforce and nCino.
16. Maintain compliance with regulations and bank policies.
17. Develop quality control metrics and communicate deficiencies to management
18. All other duties as assigned
